Revitalization Grant Program: Success

The residential and downtown revitalization grant program funds are fully allocated for this fiscal year. The City received and tentatively approved 17 residential and 7 downtown revitalization matching grant applications.

The tentative approvals allocate all of the funds budgeted in this year's revitalization program. Project applicants have been notified of their status. Several applications were received after all funds were allocated. The additional applications have been placed in a "pending" status and will be notified if any of the approved projects drop out or are cancelled by the property owner.

The revitalization matching funds program was a pilot program for this fiscal year. Any feedback, positive or negative, on the project is greatly appreciated to help determine if the project is continued in future year budget appropriations. March and April Utility Billing Period Adjustment:

The billing periods on March and April City utility bills will be adjusted to account for earlier than usual end of February meter reading schedules. The February reading (for March bills) will be read several days earlier than normal, resulting in a 27-28 day billing period. The March reading (for April bills) will be read at its normal time. The catch up for the earlier February reading will result in a April billing period that is 32-33 days long. Level Pay customers will not see any change in their City utility bill amounts.
