 I will show respect toward all coaches, players and umpires at all times and will abide by the league rules  
 I will demonstrate good sportsmanship on and off the playing fields or courts.  
 I will not fight, use foul or objectionable language or argue with coaches, referees or teammates  
 I will be coachable and ready to learn and have fun.  
 I will be a team player and will always put the team first.  
 I understand that failure to comply with the provisions of the **CODE OF CONDUCT** may result in the suspension or revocation of my privileges in any PCPR or Mid-Continent practices, games or functions.  
 I further understand that by signing this registration form I or my parent(s) Guardian(s) acknowledge receipt of this **CODE OF CONDUCT**, that I have read it, or have had it read to me, understand it and agree to comply with its provisions.

All parents/legal guardians who have children participating in PCPR or Mid-Continent Sports Association programs must abide by the following **CODE OF CONDUCT**.  
 I/We agree to support the volunteer coaches in their efforts and to never argue with a coach during a practice or game, or in the presence of any player.  
 I/We further agree not to incite or participate in Un-Sportsman-like conduct at any PCPR or Mid-Continent event or function.  
 I/We agree not to use profane, abusive or objectionable language at any PCPR or Mid-Continent activity.  
 I/We agree to abstain from the possession and drinking of alcoholic beverages and the possession or use of any illegal substance at or immediately prior to any PCPR or Mid-Continent activity.  
 I/We agree to respect all decisions of the game officials as being fair and "called" to the best of their ability.

 1) The suspension or revocation of privileges associated with a parent/guardians attendance at, or a child's participation in any practice, game or activity  
 2) The forfeiture of games and/or wins for teams whose parents and/or supporters fail to comply with this **CODE OF CONDUCT** and/or fail to comply with any subsequent disciplinary action imposed.
